Defibrillator Training- Tut! Tut!

Self-Paced Defibrillator 'Instruction' at The Shed

Just follow these 3 simple steps:-

Step 1: With the lunchroom computer turned on, go to the DESKTOP (the screen with the Sydney Harbour view).



In the top right hand corner of the DESKTOP you will see 3 icons that look a bit like this and marked VIDEO 1, 2 and 3.

Step 2:- Double 'click' on the first video icon. A YouTube video should now play. Watch, Listen & Learn. There is no need to switch on our AED but certainly take it out of the pouch and get to know what it looks like.

Step 3:- Do the same as above for videos 2 and 3. Discuss with your Supervisor. So easy !

A Change to The Men's Shed By-Laws **Please Read This**

The By-Laws of The Association provide the Management Committee with the facility to implement Policies that improve the way in which The Association is administered and in which The Shed is managed, for the benefit of members. Amendments to the By-Laws can be made by the Management Committee as deemed necessary from time-to-time.

Reason for an amendment:- We continue to grapple with the problem of dealing with unwanted tools and materials being donated to The Shed and sometimes simply being 'dumped', while at the same time not wishing to decline the good stuff.

The difficulty is in deciding at short notice what we can and would like to accept and what we definitely don't want and then being faced with disposing of ourselves.

Added to this dilemma is the fact that put on the spot to make a decision, different members & supervisors will have different views and opinions as to what is worthwhile to accept and what is not. This difference of opinion has the potential to cause embarrassment to both the well intentioned donor and to Shed members.

In order to overcome the problem of who should decide and on what basis to make a decision about accepting donated materials, it has been decided to implement an Acceptance of Donated Goods Policy as an amendment to the By-Laws.

Henceforth this will be The Policy:-

That in order to better manage donations to The Shed of both desirable and, in particular, unwanted goods:-

- Approval to accept donations of any goods whatsoever, inclusive of tools, equipment and timber may only be granted by a member of the management committee they being President, Vice-President, Secretary and Treasurer and who, at the time of implementing this policy, are Tim O'Sullivan, Tony Philps, Neil Brough & Ian Hamilton respectively.
- b. Shed members including Supervisors are not authorised to tell any would-be donor that The Shed will or might accept donations.
- The provisional acceptance of donations is c. conditional upon the donor first contacting and discussing the offer with a committee member.
- The committee member contacted by a donor as in d. clause (c) will first discuss the offer with another committee member before agreeing to the offer.
- Notwithstanding a committee member agreeing to e. an offer of donations etc. the goods so offered will only be accepted if agreed by two committee members.
- Goods offered without having first been approved / f. agreed by two committee members will not be accepted.
- Notwithstanding any of the above, The Shed may at a. any time exercise the right to refuse goods on offer even if this potentially might cause embarrassment to the donor or a shed member and
- Signage will be erected outside The Shed indicating that would-be donors must contact The Shed prior to donating any goods.

We hope that all members will appreciate the necessity for introducing this policy and will take responsibility to ensure that this policy is adhered to whenever donated goods are offered to The Shed.

So... in all cases, promise nothing and defer to the committee for a decision.

Overcoming the problem of 'dumping' and Shed Security are also under consideration !
